Here is a link to an article on the AICPA website regarding the role and responsibilities of CPAs in the maintenance of internal financial controls http://www.aicpa.org/pubs/tpcpa/feb2004/internal.htm. I have pasted the article into this note as well and have highlighted the most appropriate passage in the text. I believe that Ms. Gallas is guilty of willful blindness, at the very least. Willful blindness describes a failure of due diligence and in Ms. Gallas' case is represented by her preparation of obviously fraudulent or misleading ledger entries. While I understand that this concept may be somewhat foreign to CPAs it has been a fixture in the brokerage business for many years. The defense of "following the instructions of the client" was attempted by the CPAs and auditors at Arthur Andersen Cos. and ultimately led to their defeat in federal court and the dismantling of their organization. There does not need to be a specific regulation for the courts to find Ms. Gallas responsible for her failure to alert the board to this situation. She certainly met with the full board enough times to have done so and on this point alone she failed repeatedly. Regardless of her culpability, her actions and inactions together represent to me a deliberate attempt to deceive the JACC Board of Directors and membership or at least obfuscate the true state of JACC's finances (on this count Mr. Scott, the JACC Treasurer is also guilty). Regardless of the outcome of the upcoming elections, I intend to seek the removal of the JACC Treasurer, the termination of all future employment of Ms. Gallas by JACC and to file a complaint against her with the Enforcement Division of the Minnesota Board of Accountancy.

Internal Controls Have a Soft Side

Why human frailty can foil even sure-fire internal controls

Internal controls are hard and soft. The hard controls comprise policies,

procedures, and systems. These hard controls set the "standards" so to speak. If employees comply with policies and follow the procedures, the objectives of the internal controls can be met.

The soft controls are simply the competence, attention, and integrity of the people in an organization whose oversight helps to prevent and detect fraud. This was the basic premise introduced by John J. Hall of Hall Consulting, Inc., Chicago, in a presentation at the AICPA National Conference on Fraud, October 2–3, 2003 in Miami Beach, Florida. Along with Courtenay M. Thompson of Courtenay Thompson & Associates, Dallas, Texas, Hall offered "15 Reasons Internal Controls Break Down and What to Do about It."

First among the 15 reasons is "the process mentality." People with this mentality, according to Thompson, just go through the motions, the steps of the process, without thinking about what they're doing. He cited, for example, his experience with one organization whose accounts payable system required three executive signatures before a payment was made. In this instance, because of their inattention, the signers failed to notice that there was no payee on the check. Thompson thinks that perhaps one or more of the signers may have noticed the lack of a payee on the check. They assumed, however, that because others signed off on payment, it was all right, and therefore didn't question it.

The remedy for this reliance on process without thinking, Thompson advised, is for CPAs to educate clients (the executives) and to be aware of this mentality and its consequences when auditing.

Blind man's bluff

A second reason controls break down is blind trust. Managers may have too much faith in an employee, a faith often based on a relationship. The manager may have hired the person, trained him or her, or is related through family or some other kinship. Favored vendors are also sometimes given this blind trust. CPAs and their clients need to remember, Thompson says, that all fraud is done by those we trust and that trust is not a control.

Blindness, however, does not always result from unwarranted or even thoughtless trust. Sometimes it's deliberate. Willful blindness, choosing not to see or acknowledge a breakdown in controls, is a third reason controls break down. Hall cited an example of management's failure to question obvious red flags uncovered during an operational review of a distribution center. The number of units shipped per day and per shift was routinely charted. It was evident that during the period from December 26 through December 31, on the third shift there were not only more shipments, but also more overtime and more losses than in prior years. Despite the obvious signs of possible wrongdoing, the aberration was unquestioned. Hall also cautioned that CPAs are at legal risk if they choose to ignore such signs when working with a client.

Situational "un-" ethics

Sometimes wrongdoing goes unchallenged because of acceptance of the

situation. Hall said that this failure may occur, for example, when managers rationalize not questioning suspicious or inappropriate activity by saying to themselves, "Who am I to tell them what they've been doing wrong? I just got here."

Controls may break down because of "situational incompetence." According to Thompson, such incompetence may arise when a significant organizational change takes place related to technology or a transfer of employees. For example, a manager of an activity now being outsourced may be managing contracts instead of people. When he or she challenges the appropriateness of an activity or a contract element, the outsourcing firm may respond, "It's standard in the industry." Inexperience may influence the manager's acceptance. The outsourcer's response, says Thompson, may not be a sign of fraud, but of trouble in the arrangement.

Me first

Controls often break down because firm members put their needs before those of the organization. Subordination of needs is one of the most prevalent causes of such breakdowns. Thompson cited an example of a salesperson who generated sales of \$250,000 per quarter for three quarters. The checks received as evidence of sales would be identified later as "sent by mistake." However, reports of the stellar sales performance went up the organization's hierarchy without question. Why? This was good news for those who would also gain bonuses because of the salesperson's outstanding performance. "Positional immunity," another reason, similarly is based in the perpetrator's putting his or her needs before the organization's. The rationalization for such behavior often is "Because of who I am, the rules don't apply to me." Executives' use of the corporate jet to send children to college or to go on vacation are typical examples of such indifference. Hall cited an example of an executive who used the corporate jet to travel from the U.S. to London and kept it on call to avoid having to wait to return. Clients need to be made aware of how such behavior sets an example that encourages fraud in the organization.

Ignorance is remiss

Another reason controls break down is ignoring the fraud implications of policies and procedures. The reason managers may ignore these is that they simply don't know the implications. They don't know what they can and cannot ignore. Hall advises CPAs to assume managers and auditors may not know why certain policies and procedures provide controls to prevent and detect fraud and other wrongdoing.

Ignoring the fraud implications of reports is also a reason controls break down. For example, a report indicating an area is significantly over budget may be sending a signal that fraud is occurring. Behavioral indicators of fraud should not be ignored either. An employee living in a manner incongruous with his or her salary and without another explanation may be worth investigating.

Lack of time and information

Controls also break down when those responsible for exercising them fail to do so. Lack of time to do the control procedures may cause a control to fail. In such circumstances, those responsible may retreat to the process mentality cited above in the discussion of the first reason, which focuses on going through procedures without paying attention to what is in fact transpiring. Employees, knowing how very busy the responsible person is, may see this as opportunity to push through approvals for inappropriate or fraudulent transactions. Controls break down too because responsible employees lack information they need to assure the transactions are proper. For example, an approver may make payments without access to related contracts or may approve an invoice written in a foreign language that he or she doesn't understand.

Human frailty

Failure to enforce documentation requirements or to question "the strange, odd, and curious" is another reason controls break down. Such failure can often be explained by the fourteenth reason, conflict avoidance. Those responsible for seeing that employees comply with control policies and procedures may be reluctant to confront employees whose performance is poor or whose attitude is lackadaisical. If employees are adequately trained, directed, and supervised in their jobs, those who oversee them need to accept their responsibility not to tolerate poor performance.

Ethical, professional management sends a message down to all employees that they are expected be ethical and responsible in maintaining and applying internal controls. Fostering such a culture in an organization helps to deter fraud and other wrongdoing. Unfortunately, even in an organization that fosters ethical and responsible behavior, CPA consultants and their clients need to remember what Hall and Thompson offered as the fifteenth and final reason internal controls break down: "Those responsible for the control procedures or oversight are crooks!"

Now that we've won, where are we going? Just thought I'd share some ideas.

I think we all agree, Jerry has to go.

We need to to reopen the election of board officers. Following the November board meeting, I sent the following grievance to EB Brown:

Grievance #1

At the November 12, 2008 board meeting, the JACC board voted to extend the terms of office of two board members whose terms have expired. The members in questions were elected October 19, 2006. Two years from that date their term expired. This is in direct violation of the following JACC by-laws

Art V, Sec.1c. DIRECTORS TENURE IN OFFICE Directors shall serve a period of two years and will be elected at the General Membership meeting in October.

Sec.2a. The Board shall have up to fifteen (15) and not fewer than five (5) members.

Sec.2c. ROBERT'S RULES--All meetings shall be conducted according to stated ground rules, but the meeting facilitator may impose Robert's Rules of Order if it is deemed necessary

Since the by-laws do not address the problem incurred at the October annual meeting when the JACC executive director attempted in impose an illegal and incomplete ballot upon the voting membership, it would seem that this is one of those times when it is "deemed necessary" to impose Robert's Rules of Order. According to the 10th Edition (the latest first published October 2000):

"The unqualified wording "for a term ofyear(s)" should be avoided, because at the end of that time there would be no officers if new ones had not been elected."

While this may be an unfortunate use of terminology according to Robert's Rules, it is the terminology currently in place in the JACC by-laws. No election took place, therefore, the officers whose terms are up, are no longer board members. However, in the case of JACC, this does not leave the organization without a viable board to conduct the business of the organization. Nine board members remain active on the board with unexpired terms. According to the by-laws, the board needs a minimum of just five members in order to be viable.

As a result of this illegal action by the Board, two ex-board members were allowed to vote making a difference in the election of board officers.

The actions taken by the board at the November meeting set a dangerous precedent for any board, especially an elected one. It is undemocratic to say the least and we really have to overturn it.

We cannot really go forward until we find out where we are. I am also do not want to be held responsible for the errors of past board members and employees without knowing what they are and getting them remedied. Dottie has suggested that a committee be set up to thoroughly go through the books and records and see what's what. This would entail more than just the financial records, although they would be a prime focus. She has volunteered to help, and I suggest that we accept her help since she was our ED before all this foolishness started.

Dottie also suggested that we get a newsletter out as soon as possible. I think this would be beneficial and doable within the next 4 to 6 weeks.

I have been contacted by Roberta Englund from Fowell who wants to partner with JACC on a grant application for the Great Streets Program. She is looking at Lowry Ave. I think we can also include Broadway and Penn as well. The deadline in Feb 27. Roberta said she will write it up. We need to let the north side know that the elephant has left the hood and JACC will now play nicely with its neighbors again.

We need to plan a board retreat. JACC used to have them every year. We take a whole day (Saturday) and bring people in to teach us how to have an effective board. Also, have folks from NRP and the city come in and explain how we work with those organizations. We also take time to go over what the board priorities will be for the coming year, how to raise money and what activities we want to have during the year and more. I would suggest we do this ASAP, but not any later than February.

We talked about securing the property. I have a call into Stu Ackerberg and will talk to him about changing the locks. In the meantime, if Jerry is foolish enough to remove property from the office or destroy property or records, I suggest we make a police report and open a criminal investigation. It will help our case against him.

These are just a VERY few of the things we have to do. I suggest that we will be without staff for several months. This will necessitate extra time on our part to keep things running. I am willing to spend time in this effort, and I'm sure others will, too.

A public response from Daniel Rother to Ms. EB Brown's letter distributed by Mr. Steve Jackson at the JACC Press Conference on January 17, 2009.

It is very disappointing that a member of JACC would be so disgruntled they would come up with such poppycock. The letter goes on about the correct method removing Board Director, the implying that such a thing happened or was attempted. The truth is that there was no call for the removal of any board members and no board members were removed.

How it really happened:

The old executive committee, and in particular Mr. Jerry Moore, undermined the October 2008 election process to the extent that the annual elections had to be postponed. The City of Minneapolis and NRP had already advised that if the elections went forward under the questionable conditions that had been created, they would have been invalidated. At the annual meeting in October 2008 the membership in attendance overwhelmingly voted to postpone the elections due to the circumstances described above. Following the postponement of the annual elections the old board illegally and unnecessarily extended the terms of two board members and in the absence of an election and then voted in and seated new officers.

The illegal extension of the terms of two board members was done in violation of JACC bylaws which clearly state that board members shall serve a term of only two years. Neither one of the board members receiving an extended term was a board officer and their board tenure had

ended as called for under the bylaws. If the selection of new officers had not taken place in November the board would have still held a sufficient number of directors to meet the minimum complement required under the law. Further, the bylaws provide for new officers to be elected after the annual election so that the new board elects and seats their own officers at the first board meeting following those elections. It is that sequence of events described in the bylaws that is integral and necessary to this process. As the annual elections had not yet taken place, the elections of new board officers should not have been undertaken. Doing so was a deliberate action and had it been allowed to stand would have served to deprive any board members who would be elected in the January 2009 election their right to participate in the election of their new officers.

As a point of clarification, an assistant Minneapolis City Attorney has provided an opinion to NRP indicating that the election of new board officers following the January 2009 elections was not only a legal and proper action, but that it would have been irresponsible for the board not done so.

It is unfortunate that some members of the board (Ben Myers and EB Brown in particular) and a small part of community have chosen to characterize this as mutiny. This is participatory democracy at the grass roots level and in a democracy majority rules. The fact that the old officers would describe and publicize this as "mutiny" is a disservice to the community they claim to serve and a distortion of the truth by a disgruntled few who failed to get their way.

After new officers were elected on January 14, it was discovered that the old officers, like thieves in the night, came in and removed from the JACC offices at 2009 James Avenue North computers, fax/copier, financial documents, and the check book and check register. This

action was taken without board knowledge or approval and can only be considered out right theft. The removal of this property has rightfully been reported to the Minneapolis Police Department as a theft. This type of vigilantism is especially troubling because we expected better from someone like Ben Myers who is a licensed attorney (at the time of this writing). Ben Myers has announced publicly that he has knowledge of the location of the property that has been reported stolen. I speculate that the level of desperation shown here is directly in proportion to the level of malfeasance that will be discovered when we retrieve the records. Mr. Ben Myers and Ms. EB Brown have additionally failed to disclose what authority they believe they have to act outside of a board meeting and remove any JACC property from the established JACC offices.

JACC did hold a regularly scheduled board meeting in January and it did not adjourn until the time ran out at about 7:45pm. There was a portion of the meeting that was closed to the public to discuss an employee's conduct, which I will not comment on in a public forum. This was on the agenda (nothing hidden here) and that agenda was adopted by the majority in a vote by the Board Members in a public meeting. It must also be recognized that part of the Executive Committee's role is to "propose" an agenda for the board but it does not become the agenda unless it is adopted by the Board of Directors, by a majority vote.

As for JACC being the fiscal agent for any other organization; that action was taken without board prior knowledge or approval. To make matters worse, Board Members have not been made privy to any substantive financial information including bank statements dated between July of 2008 and today. In fact Mr. Jerry Moore reported that he has sublet the office in the past to other businesses and done so without proper disclosure or documentation to the Board of Directors and also

includes hired and paid employees unbeknownst to the board. It also appears now that Mr. Ben Meyers or Mr. Jerry Moore may have told the counselors (for whom JACC may be the fiscal agent) they had to be out of the office by Friday, this action did not come from the current officers as it is alluded to in Ms. EB Brown's letter.

It is also worth mentioning that no member from the old board has brought forward any youth programs in the past year except in secret meetings that the full board was not invited to and no recorded minutes of such meetings have been made available other board members despite multiple requests to provide minutes from those meetings.

I sincerely hope wish and encourage the old officers to bring forward any grievances they may have or to seek mediation rather than to continuing on this injurious path of acting outside the law and further damaging their credibility in the community. Mr. Myers please return to the community the property reported as stolen from the JACC office at 2009 James Avenue North.

On another note Jane Northside failed to do her research in a recent article before going to print. If she had she would have know that every candidate went though the same process for vetting. Just sending your autobiography to the nominations committee was not good enough for any candidate to get on the ballot. All candidates had to verify their residency, or that they worked in the neighborhood, or that owned property or a business here. Documentation could come from a Hennepin County property record, or a written statement from an employer or landlord etc. Unfortunately one individual repeatedly was sent requests for such written documentation over and over and over again in writing and in documented phone calls and failed to respond at all until the vetting process was

closed! This individual was given more opportunities than any other to respond and failed to do anything until it was too late.
